## **Policy Statements and Updates**

#### Congress Passes COVID-19 Relief Bill with MCH Priorities, Sends Bill to President for Signature

Today, the U.S. House of Representatives passed the final version of the latest COVID-19 relief bill, the *American Rescue Plan Act* (H.R. 1319), which has a top-line funding level of \$1.9 trillion and includes several priorities for maternal and child health and public health infrastructure. The Senate passed the bill

last weekend, which means the *American Rescue Plan Act* now heads to President Biden for his signature to become law.

Major provisions to support maternal and child health and public health infrastructure more broadly include:

- **\$150 million** in emergency supplemental funding for the **Maternal**, **Infant and Early Childhood Home Visiting (MIECHV)** program. For details, see pages 44-45 of <u>this summary</u>.
- A provision to support state efforts to **extend Medicaid coverage to 12 months postpartum** by creating a new Medicaid state option to pursue this policy. Note: The final bill makes the option available to state for 5 years.
- **\$7.66 billion** to establish, expand, and sustain a **public health workforce**. For details, see page 14 of <u>this summary</u>.

### **Funding Opportunities**

#### FY 2021 Funding Opportunity Announcement

The Office of Minority Health (OMH) at the U.S. Department of Health and Human Services administers grant programs to support projects that implement innovative models to improve minority health and reduce health disparities.

OMH has released a new funding opportunity announcement (FOA) for which applications are now being accepted.

This notice solicits applications for projects to demonstrate the effectiveness of local government implementation of evidence-based health literacy strategies that are culturally appropriate to enhance COVID-19 testing, contact tracing and/or other mitigation measures (e.g., public health prevention practices and vaccination) in racial and ethnic minority populations and other socially vulnerable populations, including racial and ethnic minority rural communities. Applicant eligibility is limited to localities (e.g., cities, counties, parishes, or other similar subdivisions). OMH encourages applicants to partner with a Minority Serving Institution for quality improvement activities and program evaluation.
