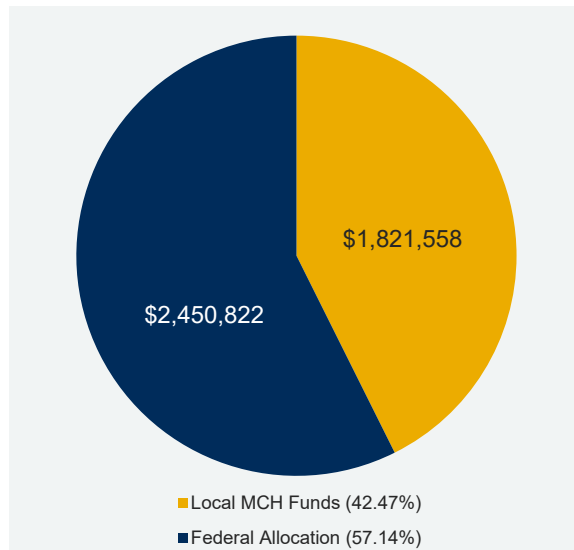
## Maternal and Child Health Block Grant 2023

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2021, 92% of all pregnant women, 98% of infants, and 58% of children nationwide benefitted from a Title V-supported service. ## State spotlight: Special Healthcare Needs and Newborn Screenings

Through the Idaho Children's Special Health Program, approximately 75 uninsured children with specific diagnoses receive financial support for diagnosis and treatment. More than one-thousand pediatric visits occur at specialty clinics around the state. Idaho's Newborn Screening Program contracts with the Washington State Public Health Laboratory to screen more than 22,000 babies annually for 51 conditions. Pediatric specialty physicians and nutritionists provide support and care for the diagnosis and treatment of infants.

## Current Special Projects of Regional and National Significance (SPRANS)

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
