## Maternal and Child Health Block Grant 2023

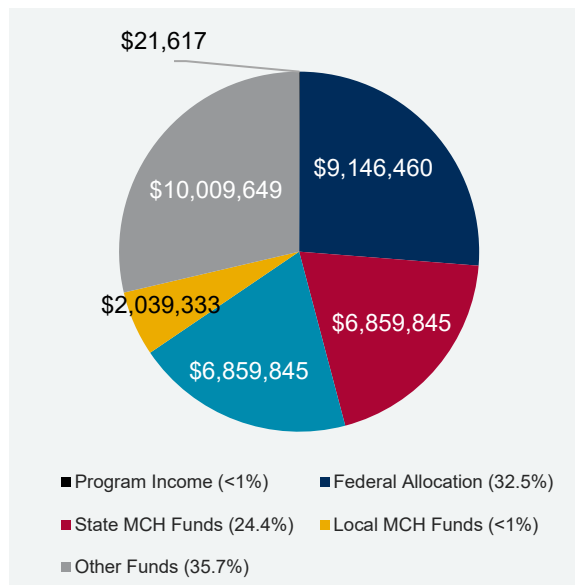
The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2021, 92% of all pregnant women, 98% of infants, and 58% of children nationwide benefitted from a Title V-supported service. ## State spotlight: Help Me Connect Online Navigation and Referral System

Launched in 2021 in response to community identified needs, Help Me Connect (HMC) is an online navigator that connects expectant families and those with young children, up to 8 years of age, with services in their local communities that support healthy child development and family well-being. The navigator welcomes 11,000 unique visitors per month to the site and is being used throughout all regions of Minnesota, as well as neighboring states. Over 1000 new resource listings were added in 2022, and the site was also translated into Spanish, Somali, and Hmong.

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
