
Maternal and Child Health Block Grant 2023

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2021, 92% of all pregnant women, 98% of infants, and 58% of children nationwide benefitted from a Title V-supported service. To learn more about Title V, visit www.amchp.org.

State spotlight: Nevada 211

As a special telephone number reserved in Nevada, 211 provides MCH information and referrals to statewide health and human services organizations. Operators are updated with current resources and information to support the MCH population, including assisting pregnant women seeking prenatal care services. Bilingual (English/Spanish) operators are available. In addition to calling 211, Nevada residents can also text their fivedigit zip code to TXT211 (898211) to receive assistance via text message and/or visit the website at Nevada211.org. Nevada 211 integrates with the Medical Home Portal.
