
Maternal and Child Health Block Grant 2023

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2021, 92% of all pregnant women, 98% of infants, and 58% of children nationwide benefitted from a Title V-supported service. To learn more about Title V, visit www.amchp.org.

State spotlight: Infant Mortality

The Preparing for a Lifetime: It's Everyone's Responsibility initiative is a state-wide infant mortality initiative. This initiative has over 40 partners throughout the state working together to address top issues in infant mortality in Oklahoma, such as being healthy before becoming pregnant, carrying babies to full-term when possible, maternal mood disorders, tobacco prevention/cessation and secondhand smoke exposure during pregnancy, breastfeeding, safe sleep, abusive head trauma and encouraging and supporting pregnant women's healthy choices. Since beginning this initiative in 2007, infant mortality has decreased by over 20% allowing many more Oklahoma babies to celebrate their first birthdays with their families.

Current Special Projects of Regional and National Significance (SPRANS)

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
