#### **Maternal and Child Health Block Grant 2023**

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2021, 92% of all pregnant women, 98% of infants, and 58% of children nationwide benefitted from a Title V-supported service. #### State spotlight: Newborn Screening

Infants born in South Dakota receive blood spot screening and hearing screening prior to hospital discharge. The goal of newborn blood spot screening is to identify newborns at risk for life-threatening and debilitating conditions that would otherwise not be detected until damage has occurred, and for which intervention and/or treatment can improve the baby's outcome. South Dakota screens for **36** core conditions listed **on** the Recommended Uniform Screening Panel (RUSP) of the Secretary's Advisory Committee on Heritable Disorders in Newborns and Children. All infants whose newborn blood spot screening test results are outside of the normal limits for a newborn screening disorder receive follow-up to ensure prompt and appropriate follow-up testing. South Dakota Newborn Screening Program facilitates a Newborn Screening Advisory Committee comprised of pediatric specialists, laboratory personnel, nurses, pediatricians, families, and community members.

### **Current Special Projects of Regional and National Significance (SPRANS)**

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
