
#### **Maternal and Child Health Block Grant 2023**

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2021, 92% of all pregnant women, 98% of infants, and 58% of children nationwide benefitted from a Title V-supported service. #### State spotlight: Women and Infant Health Program

The Women and Infant Health Program reviews maternal deaths as part of a cross-state Maternal Mortality Review Committee (MMRC). The purpose of these reviews is to come up with recommendations that would have possibly prevented the maternal death. The program also funds and coordinates the Wyoming Perinatal Quality Collaborative (WYPQC). The WYPQC has begun initiatives based off the recommendations from the MMRC. The WYPQC holds quarterly meetings focusing on topics pertaining to access to care and improving standards of care for women and infants in Wyoming. The program participates in a Association of State and Territorial Health Officials (ASTHO) learning community to improve access to care for women with substance use disorder and their substance exposed infants.

### **Current Special Projects of Regional and National Significance (SPRANS)**

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
