Emerging MCH Professional Award

Description

In 2014, the Emerging (formerly titled Young) MCH Professional Award was developed to recognize current/future leaders for their significant contributions to their state MCH programs in promoting and protecting the health of women, children, and families in their state and/or region. This award recognizes outstanding state or local MCH professionals under age 45 or with less than 10 years of experience whose work has made substantial contributions to their state's MCH program, their state's MCH outcomes, or made other significant contributions to promoting and protecting the health of women, children, and families in their state. It recognizes an individual's capacity to perform above and beyond expectations, using creativity and innovation to address pressing MCH challenges, and their emerging and future leadership potential. Up to ten awards, a maximum of one from each HHS Region, will be conferred annually. The recipients will be recognized at AMCHP's Annual Conference.

Criteria

Nominees for the Emerging MCH Professional Award must meet the following criteria:

- Nominee must be 45 years of age or younger or with less than 10 years of experience
- Demonstrate individual capacity to perform above and beyond expectations, using creativity and innovation to address pressing MCH challenges, and their emerging and future leadership potential.
- Be an AMCHP member OR their organization/agency must be an AMCHP member at the time of the nomination.
- Be employed by a state health agency or health-related partner whose mission focuses on MCH issues (i.e. March of Dimes, AAP, Family Voices, Healthy Mothers/Healthy Babies, etc.) Employment may be part or full-time, internship, fellowship, etc.)
- If the nominee is not a Title V/MCH/CYSHCN director or AMCHP delegate, a letter supporting the nomination must be submitted by the state Title V/MCH/CYSHCN director or a state AMCHP delegate.
- Candidate may not be a current, active member of the AMCHP Board of Directors or Staff.

Selection Process

Up to ten (10) awards will be made annually from a pool of nominations solicited nationwide. AMCHP will issue a call for award nominations via AMCHP Pulse, Member Briefs, the AMCHP website, and blast emails to all AMCHP contacts approximately six months prior to the Annual Conference. Nominations will close and all materials must be submitted approximately five months prior to the Annual Conference. The AMCHP Region Directors will conduct the initial vetting of all nominations within their region using an identified process with the states in their region and submit a single recommended candidate to the Governance Committee from their specific region.

The Governance Committee reviews and approves the final recommendation for consideration by the Board of Directors. Nominees are notified of the final status of their submission approximately three months prior to the Annual Conference. The Emerging MCH Professional Award is awarded during the AMCHP Annual Conference. This award may not be awarded annually in each of the ten HRSA regions.

Special Travel Funding

Awardee will receive full conference registration of their choosing (in-person or virtual).

This award includes support for one (1) hotel night to attend the AMCHP Conference to accept the award in person.
