Maternal and Child Health Block Grant 2024

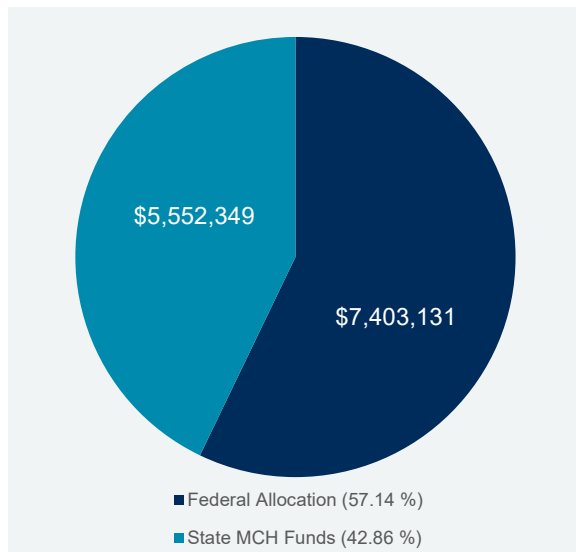
The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. State spotlight: Maternal and Child Health

Colorado's Maternal and Child Health (MCH) program is housed in the Colorado Department of Public Health and Environment (CDPHE) and collaborates with programs across CDPHE, other state agencies and statewide organizations, local public health agencies and community partners to implement strategies that have a population-based impact on Colorado's statewide MCH priorities. The 2021-2025 priorities were selected based on issues identified through the comprehensive MCH statewide needs assessment process conducted in 2019.

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
