Maternal and Child Health Block Grant 2024

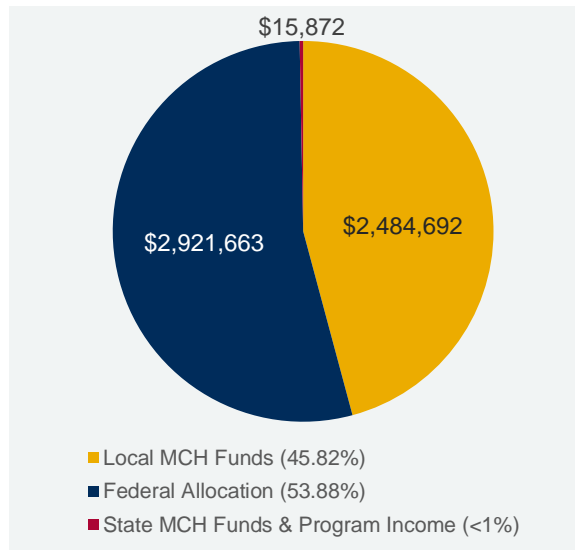
The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. State spotlight: Special Healthcare Needs and Newborn Screenings

Title V funds support the Newborn Screening Program, which screens over 99% of Idaho babies for various disorders and ensures babies are linked with appropriate follow-up care. Idaho's Newborn Screening Program contracts with the Washington State Public Health Laboratory to screen more than 22,000 babies annually for 51 conditions. In February 2022, four new conditions were added to Idaho's Recommended Uniform Newborn Screening Panel: Glycogen storage disorder type II (Pompe Disease), Mucopolysaccharidosis type I (MPS-1), X-linked adrenoleukodystrophy (X-ALD), and Spinal muscular atrophy (SMA) were added to Idaho's RUSP. Approximately 75 uninsured children with specific diagnoses receive financial support for diagnosis and treatment through the Idaho Children's Special Health Program. Pediatric specialty physicians and nutritionists provide support and care for the diagnosis and treatment of infants.

Current Special Projects of Regional and National Significance (SPRANS)

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
