
#### Maternal and Child Health Block Grant 2024

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2022, 93% of all pregnant women, 99% of infants, and 61% of children nationwide benefitted from a Title V-supported service. ### State spotlight: Mississippi Perinatal Quality Collaborative

The Mississippi Perinatal Quality Collaborative (MSPQC) is a statewide partnership that promotes evidence-based quality improvement initiatives at the hospital and community level to improve birth outcomes across Mississippi. MSPQC relies on collaborative data driven projects to address specific drivers of maternal and neonatal morbidity and mortality. These projects are selected by participating collaborative members across the state, who work to develop, disseminate, and successfully implement best practices in all clinical settings caring for mothers and infants. While working collaboratively, the MSPQC has three divisions: Neonatal, Obstetric and Family Engagement & Public Health.

## **Current Special Projects of Regional and National Significance (SPRANS)**

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
