
#### Maternal and Child Health Block Grant 2024

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2022, 93% of all pregnant women, 99% of infants, and 61% of children nationwide benefitted from a Title V-supported service. ### State spotlight: Early Childhood Health

Early identification of developmental delays and social-emotional challenges is a critical priority. Core program components include training providers to support parents in completing Ages & Stages Questionnaires and identifying and promoting best practices that assure families receive appropriate referrals for further assessment, specialized intervention, or ongoing monitoring. Close partnership with the Maternal, Infant, and Early Childhood Home Visiting program, Healthy Start, the Resource Mothers Program, and the Early Childhood Comprehensive Services (ECCS) initiatives creates a workforce poised to seamlessly support health, development, learning, and school success. The ECCS focuses on aligning prenatal-to-three systems through developmental monitoring activities from Virginia Ready Regions and the CDCs Learn the Signs, Act Early! The strong partnership with Title V's Children and Youth with Special Health Care Needs Program and the statewide network of Child Development Clinics supports the critical continuum of care by conducting comprehensive developmental screenings and ensuring alignment with supportive services in the community.

### **Current Special Projects of Regional and National Significance (SPRANS)**

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
