
### **Maternal and Child Health Block Grant 2024**

The Maternal and Child Health Services Block Grant, Title V of the Social Security Act, is the only federal program devoted to improving the health of all women, children, and families. In Fiscal Year 2022, 93% of all pregnant women, 99% of infants, and 61% of children nationwide benefitted from a Title V-supported service. ### State spotlight: Physical Activity & Nutrition

The Wisconsin Title V program offers an opportunity for local and tribal health agencies in their state to address physical activity and nutrition needs in children ages 6-11 years old. Title V staff and state-wide partners – healthTIDE and the University of Wisconsin Division of Extension Health and Well-Being Program – train and provide technical assistance to agencies around partnership building and implementing policy, systems, and environmental changes that support optimal nutrition and physical activity. Participating agencies complete the Systems Approaches for Healthy Communities course from the University of Minnesota to gain a foundational knowledge of policy, systems, and environmental changes and community engagement and outreach principles. Peer Learning Calls support participants in applying module content and peer-to-peer learning and networking through small group discussions. One-on-one coaching for agencies moving towards implementation provides specific support and resources tailored to each agency's unique needs.

## **Current Special Projects of Regional and National Significance (SPRANS)**

Special Projects of Regional and National Significance (SPRANS) funding complements the formula funding each state receives and helps ensure the success of state Title V, Medicaid, and CHIP programs by driving innovation, responding to emerging and entrenched issues, and building capacity for integrated systems of care for women, children, and families.
