INCREASE FUNDING FOR

CDC's Safe Motherhood Portfolio

The Association of Maternal & Child Health Programs (AMCHP) calls on Congress to fund the Centers for Disease Control and Prevention's (CDC's) Safe Motherhood program at \$164 million for FY2025.

CDC data showed that the number of pregnancy-related deaths in the United States continued an upward trend in 2021, with over 1,205 deaths and Black and indigenous women disproportionately impacted. Further, CDC released provisional data indicating that the total infant mortality rate in the U.S. increased by 3% from 2021-2022. This portfolio of programs at CDC supports a broad range of activities that seek to improve the health of moms and babies and reduce disparities in maternal and infant health outcomes. \$164M for the Safe Motherhood and Infant Health line would enable CDC's Division of Reproductive Health to expand its successful programs from specific jurisdictions to nationwide.

Enhancing Reviews and Surveillance to Eliminate Maternal Mortality (ERASE MM) and Maternal Mortality Review Committees (MMRCs)

MMRCs are multidisciplinary review committees in each state that are tasked with reviewing each death that occurs during or within a year of pregnancy (pregnancy-related deaths). MMRCs develop comprehensive, data-driven recommendations for the state health department, PQCs, and other health care and public health entities to actualize.

Perinatal Quality Collaboratives (PQC)

PQCs are state or multistate networks of teams working to improve the quality of maternal and infant care. They identify processes within the local health care and public health systems that need improvement and find solutions that can be implemented swiftly. Currently, there are 36 states with CDC-funded PQCs out of 50 total programs. PQCs have contributed to the following changes:

- Reduction in deliveries before 39 weeks of pregnancy without a medical reason
- Reductions in healthcare-associated bloodstream infections in newborns
- Reductions in severe pregnancy complications
